Ethos Facilities will undertake to:

- Reduce Scope 1 and 3 emissions by 42% by 2030 as near-term milestones.

- Enhance the operational potential of existing equipment and develop and apply robust carbon-cutting strategies.
- Ensure where possible all goods and products are purchased from sustainable & ethical sources.
- Make efficient use of energy and water resources and reduce our carbon footprint.
- Implement vehicle trackers on all vehicles to reduce wasted journeys and lessen our impact on highly congested areas.
- Continue to increase our fully electric van fleet and only purchase and operate fuel-efficient vehicles, therefore, reducing our carbon footprint significantly.
- Source 80% of electricity from renewable sources by 2025 and 100% by 2030-
- Implement robust GHG monitoring, accounting, and reporting practices to track progress and drive improvement.
- Engage suppliers to promote sustainable procurement practices and reduce embedded emissions.
- Deploy building energy efficiency upgrades and expand on-site renewable energy installations.
- Support and educate employees to take part in low-impact commuting, energy-saving initiatives, and sustainable decision-making.
- Continually improve measurement and reporting of waste collected on behalf of all clients.
- Work with other service providers to extend the waste consolidation strategy across our portfolio.
- Ensure we integrate environmental and sustainability considerations into our business decisions.
- Maintain an Environmental Management System (EMS) in accordance with the requirements of ISO 14001:2015
